All data necessary to replicate (or improve upon) our genome assemblies are publicly available through NCBI. Taxon sampling is described in the "Materials and Methods" section of the manuscript. Briefly, samples were sequenced because laboratory strains and/or collections were readily available and to improve the biological diversity of available *Drosophila* genomes.
