Sample size was estimated based on previous experiments done either in our lab or in our collaborators' lab. For these well-established techniques, routinely performed in our lab, adequate sample size were previously determined by formal power analysis. For some experiments, such as CLAMS, for a given experiment, the experimental sample size was determined by the number of metabolic chambers available (a total of 16). If the chamber number was not sufficient to lead to an adequately powered study or if trends were identified, additional cohorts of mice were assigned to these experiments to increase the power.

Replicates

Where applicable, the numbers of technical and experimental replicates are indicated in figure legends. Outliers were identified using the “find outliers” function in the GraphPad Prism software. Technical replicates were eliminated if a technical problem was identified (low-quality RNA, or a stain on a immunoblot, for example). Most experiments used for metabolic phenotyping of mice was performed in at least two separate cohorts of mice. Biological replicates are represented as individual dots in the bar graphs.

Statistical reporting

The statistical analyses comply with the Journal requirements. Statistical analysis methods are described in the methods section and in the figure legends. For all graph bars, the raw data for biological replicates is represented as individual dots. P-values are reported in the figure legends.

Several cohorts of animals were used for the different experiments. Littermate control mice from the different genotypes were randomly assigned to the different experiments and treatments. Whenever possible, investigators were blinded to animals' genotype and treatment.
