Sample-size estimation is not provided in this manuscript as we have run sample-size estimation on previous studies (reported in our IACUC protocol to adhere to animal use rigor and responsibility guidelines) with similar study design and population to the experiments in this manuscript.

Each experiment was run once and the definition of biological vs technical replicates is not applicable as each animal represents one biological replicate. All experiments were performed with a minimum of three biological replicates. Sample size is provided for each experiment in the figure and figure legend. We did not encounter any outliers so we do not describe criteria for exclusion/inclusion of data. However, we are happy to include this information under the statistics section of our manuscript if needed. High-throughput sequence data has been uploaded to GEO and we would be happy to provide a private link for reviewers.
