In this computational study, the default network size is 3600 neurons. Sensitivity analyses involving different network sizes (1600, 2500, 6400, 14400 neurons) are also presented. Detailed sensitivity analyses are incorporated involving different model configurations and input scenarios. Data representation across figures includes all data, and not just summary statistics. Different forms of heterogeneities (afferent, synaptic and intrinsic) were introduced by uniform sampling the specific parameter over different ranges (to control the degree of heterogeneity).

#### Replicates
