Each participant took part in 3 sessions of 10 trials each, which may be considered as biological replications (all in one day, all collapsed for the analyses or split into even and odd for the split-half reliability analysis). We did not encountered outliers.

The criteria for excluding segments of pupillometric recordings are reported in the text (page 17; "Pupil and gaze tracking analyses" section). No high-throughput data was obtained.
