No statistical method was used to predetermine sample size. The large number of microtubules and single molecules analyzed ensures that clear differences (and/or lack of differences) can be detected and measured between conditions, consistent with other publications in the field.

The information pertaining to the number of experimental repeats is stated in the figure legends. In this study we define biological replicates as independent experimental repeats performed on different days. The criteria used for data exclusion and outlier analysis are specified in the methods.

Statistical significance was determined by Welch's t-test and Student's unpaired t-test, as indicated in the text and figure legends. Sample size, detailed information of the plot content and precision measures (mean, SD or SEM) are also stated in the figure legends.
