No ethical considerations regarding sample size were necessary as the study deals with common laboratory insect model (*Gryllus*). The validation of experimental results did not require a prior calculation of sample-size since the described knockdown experiments resulted in highly penetrant phenotypes.

The conclusions of the paper rest on RNAi knockdown experiments which were performed according to the highest standards of the field (as in our former studies). The experimental procedure is reported in the section "Parental RNAi experiments" (see Material and Methods). RNAi knockdown for *Gryllus* Toll1 was repeated using nonoverlapping fragments to test for variation in the knockdown strength and potential second site effects. There was no indication for second site effects. Furthermore, the independent knockdown of components of the same pathway produced an identical or nearly identical spectrum of phenotypes. This provides mutual support for the specificity of the knockdown phenotypes.
