This manuscript presents baseline data. We determined sample size in the design of the study by calculating the minimum detectable incidence rate ratio for a single binary exposure assuming 90% power, a two-sided  $\alpha=0.05$ , average 3 years of follow-up per person, 500–1500 persons, an incidence in the unexposed group ranging from 2–8 per 100 PY and covariates associated with the outcome at  $R^2=0.30$ . Our final sample size of 2,512 exceeded sample size requirements.
