No explicit power analysis was used. This is uncommon in single-cell projects, where a large proportion of the power is derived from the number of cells per included subject. Based on previous studies we included 8 subjects per disease group, and four controls as we expected lower inter-subject variability in this last group.

Our setup is described in detail in the method section, our groups were: eight patients with COVID-19, eight matched patients with CAP-other and four matched controls.

In Figure 3-5 we compare 8 CAP-other patients vs 8 COVID-19 patients.
