The sample size was partly based on our previous publications where we found that the effect of sleep deprivation on clock gene expression is reliable detectable at n=5. Moreover, a previous study using partly the same technique (Saini et al., 2013, Gen Dev) found a sufficient detectable effect with a similar number of animals (5 mice per group) as ours (Fig1: 5 and 6 mice; Fig2: 6 mice; Fig3: 4 mice).

Experiments were performed in several batches (i.e. 2 mice per experiment) because only two mice at the time could be recorded alongside in the RT-biolumicorder. For the tethered EEG experiments, the same number of experimental batches (3) applied. All experiments were performed on biological replicates (different mice), hence the differentiation between technical and biological is not applicable here. The number of mice used is indicated in the figure legend, and outlier-like behavior was discussed in the results section and not excluded from analysis. No data has been excluded from analysis.
