Our sample size reflects a convenience sample that took 3 years to collect including all opportunities for recruitment/data collection. This sample size matches or exceeds the sample size of most published studies of intracranial recordings during DBS surgeries.

This information does not apply to our submission. Replication of the experiment was not conducted as part of the described investigation because infrequency of opportunities for intracranial recording in humans made this unfeasible. (Described experiment took 3 years to complete.)

Research participants were not assigned to experimental groups. However, we compared participants across unassigned groupings (at which site they received DBS implantation. Before doing so, we confirmed that behavioral performance did not indicate differences in strategy that would preclude such a comparison. (See Results, p. 7.)
