There a number of different types of experiments in this study, where a few different statical tests were appropriate. In the Methods section, we list the different tests used in the manuscript, and specific tests, p values, and sample size are listed in the figure legends. Mean and SD are identified for bar graphs. Raw data is shown either in isolation or overlaid onto graphs (for example, as individual datapoints overlaid onto bar graphs of Mean +/- SD) where informative.
