Each individual *in vitro* experiment is considered as one biological replicate. Each individual animal is considered as one *in vivo* biological replicate. The information on number of replicates is provided in the legends of each figure.

Biological and independent replicate experiments were successful. They were replicated independently by the first author.

No data were excluded from the analysis.

Depending on the type of experiment, presented data sets differ: In example:

For each *in vitro* experiment, data obtained from all biological replicates are pooled to generate each figure.

For *in vivo* experiments, based on the type of experiment, each point presents either data from an individual mouse (such as q-PCR results) or an individual muscle fiber (such as mitochondrial organization).

The precise data type/group used for generating each figure is described in the figure's legends and detailed experimental raw data can be found in the "source data" files.

No randomization was applied to in vivo studies and only male mice of the same age were cross-analysed to generate the data.

Animal experiments were blinded when possible.
