Sample sizes were not computed in advance. Fig 1 summarizes all the experimental work; each point in Fig. 1G corresponds to a different sample, and our goal with all 7 experimental samples was to explore a broad range of wavelengths and pore sizes. The simulations (summarized in Fig 2) were designed to match the experiments.

### Replicates

Fig 1 summarizes all the experiments; each point in Fig. 1G corresponds to a different independent sample testing different wavelengths and pore sizes, without any additional replicates.
