We did not exclude statistical outliers; any data excluded was for obvious confounds that corrupted the data (defective blot transfer or corner effects; failed positive or negative controls)

Key *in vitro* findings were replicated by two independent researchers (Conde-Dusman, and Dey). All attempts at replication were successful.
