Bone slices from independent mice were used for Ca<sup>2+</sup> imaging. These details are described in the Materials and Methods section. For gene expression analysis, growth plate sections enriched with round and columnar/hypertrophic chondrocytes were historically dissected from femoral bones. This enrichment was confirmed by expression level of marker genes. These are described in the figure legends of Figure 1-figure supplement 2.
