Sample sizes were not computed in advance. Unless stated otherwise, infections of BMDMs with Mtb were performed 3 times (corresponding to the 'n' value given in figure legends), with the same Mtb and BMDM preparations but in distinct wells handled separately; and each of the shown experiments was repeated at least once independently.
