Sample sizes were determined based on variance from previous experiments in the lab for hearing tests. or other experiments, sample size was determined from variance observed from pilot experiments. Sample size is noted in figure legends and sample size calculation is described in the Statistical Analysis subsection of Materials and Methods.

### **Replicates**

- You should report how often each experiment was performed
- You should include a definition of biological versus technical replication
- The data obtained should be provided and sufficient information should be provided to indicate the number of independent biological and/or technical replicates

Technical replicate number (number of times each experiment was repeated) is described in the figure legends. The number of biological replicates (n, number of organs or mice) is also listed for each figure panel.

## **Statistical reporting**

- Statistical analysis methods should be described and justified
- Raw data should be presented in figures whenever informative to do so (typically when N
  per group is less than 10)
- For each experiment, you should identify the statistical tests used, exact values of N, definitions of center, methods of multiple test correction, and dispersion and precision measures (e.g., mean, median, SD, SEM, confidence intervals; and, for the major substantive results, a measure of effect size (e.g., Pearson's r, Cohen's d)
- Report exact p-values wherever possible alongside the summary statistics and 95% confidence intervals. These should be reported for all key questions and not only when the p-value is less than 0.05.

The Statistical Analysis subsection of the Materials and Methods describes the statistical tests used in the manuscript. Figure legends indicate the value N and p-values for each comparison. The SEM values and the mean are indicated on graphs and in the text.
