In Figure 1b, Figure 2b and 2c, Figure 4b, Figure 5b statistical significance was determined with one-way ANOVA followed by Tukey's multiple comparison test comparing the different groups. (\*p < 0.05; \*\*p < 0.01; \*\*\*p < 0.001). The data were analyzed using the Prism 5.0 software program (GraphPad Software, La Jolla, CA, USA).
