Sample size of cryo-EM data sets was chosen based on the resolution of the refined EM map. Details (# micrographs and particles) are given in Tables 1-4 and Table 6.

Not applicable to cryo-EM studies. The computed 3D maps represent an averages of hundred thousands of individual 2D particle images.

The resolution of cryo-EM maps was estimated based on the 0.143-Fourier shell correlation criterion, using two independently refined-half maps (gold standard), see Methods. Symmetry parameters represent mean values and their standard deviation. Each F-actin subunit was aligned to all other subunits within a pentamer, resulting in 20 unique matches (data points), see Table 5.

Single particle datasets are split into random halves for 3D reconstruction (based on the filament ID). 3D masks were applied to exclude solvent area surrounding particle images, see Material and Methods for details.
