For Figures 1-4 and S1-4, necessary biological replicates per experiment were determined based on previously published literature.
For histological analysis (Figure 1 and Figure 5), sample size was restricted to the limit approved in the Ethics Protocol.

Replicates

For Figures 1-4 and S1-4, a well of a tissue culture plate with cells from a single donor or cell line was considered a biological replicate. An experiment consisted of 3-5 biological replicates per group.

For histological analysis (Figure 1 and Figure 5), randomly selected cells from each donor sample were considered a biological replicate, and each analysis included 3-6 samples per group. Criteria for identifying outliers and replicate exclusion, and where was applied, are described in the Material and Methods.

The number of replicates and experiments are reported in the corresponding figure legend.



Statistical reporting
