In vitro characterization of binding properties experiment was carried out at least three times. The replicates is indicated in figure legend of figure 2 and figure 3. The SPR and the BLI experiment was performed at least twice. The initial experiments were to test the range of variables that can lead to reliable fit of the data to get the kinetic parameters. These variables include analyte concentration used for the measurements in Supplementary Figure S1 and Supplementary Figure S5. The final data reported is the dataset acquired after optimizing all these variables and giving reliable fitting parameters through global fit of all the data points at different analyte concentrations in both association phase and dissociation phase.
