No explicit power analysis was used. Detailed information about sample size can be found in the figure legends. At least 5 flies and tens to hundreds of cells were used for each condition and genotype. The number of flies in behavior and flies (cells) in calcium imaging was similar or bigger than in previous articles using the same methods. All statistics were done between flies, to avoid underestimation of the error. Details can be found in the "Behavioral analysis" and "Two photon data analysis" sections of the material and methods.

For behavioral experiments, each fly was considered a biological replicate. Flies with forward walking speed below a threshold (2mm/s) were discarded from every experimental condition. Further details can be found in the Material & Methods section of the manuscript.

For 2 photon imaging, each fly (but not cells within one fly) was considered a biological replicate. Further details can be found in the Material & Methods section of the manuscript.
