Sample size used previous work proved sufficient and were replicated here. Since kinetic proofreading effects were previously found to be quite large, we continued with three biological replicates per reporter.

Replicates

The same definition of biological and technical replicates previously used is also used in this work, and is included in the methods under "Biological and technical replicates." The number of biological replicates is explicitly called out in the legends of Figure 4 and Figure 5. Criteria for excluding cells from analysis can be found in the methods under "Criteria for including or excluding cells in analysis."

Statistical reporting
