Information regarding replicates can be found in the appropriate methods section. For behavioral data, individual events were shown in scatter plots. For calcium imaging, individual peak ratio changes are shown in scatter plots, alongside representative traces. For intestinal lumen pH imaging, total luminal florescence boxplots and outliers are shown. Outliers were included, and non-parametric tests were used to analyze the data to control for outliers as non-parametric tests are based on ranks and are not affected by extreme values. Increased variation (and thus outliers) is an important feature of some of our data, so coefficient of variance was used as a measure to capture this.
