Sample size for electrophysiology experiments was based on previous extensive experience. While sample size for chemogenetic experiments was based on numbers used in comparable published studies.

N values for rats and cells are given were appropriate throughout the text and figures.

In the results and methods section, we reported the number of animals, single units and trials used for each analysis. Individual data points are reported in all graphs.
