We chose a fixed number of 4 different initial conditions for each network simulation, providing good statistics and using reasonable computational resources. This information is indicated in captions of Fig. 3, 4, 5, 6 and Table 1. Datasets used for simulations are CIFAR-10 and SVHN (see section 4.2.). The usual splits for these datasets were used: 50,000 training images and 10,000 test images for CIFAR-10, and 73257 training images and 26,032 test images for SVHN.
