### Statistical reporting

- Report exact p-values wherever possible alongside the summary statistics and 95% confidence intervals. These should be reported for all key questions and not only when the p-value is less than 0.05.

We identify statistical test within body of text and the figure legends. We report all N values within figure legends.

For electrophysiological experiments we report 'n' as the number of cells recorded from.

For histological experiments we report the number of animals for qualitative interpretations and both the number of animals and cells counted for quantitative analyses.
