The sample size was not pre-determined computationally. For biological activity assays $N = 3$ (repeats) was used. For cryo-EM data collection, the sample size (three datasets) was determined based on final achievable resolution of the 3D reconstruction after image analysis.

Replicates

The details about the sample sizes can be found in the figure legends (Figure 1, Figure 5, Figure S1). The cryo-EM data analysis (including the 2D and 3D classification as part of image analysis) is described in Methods, Figure S2 and Table S1.
