No power analysis was used in this study. A minimum of 3 biological replicates were used per condition for every experiment reported. More than 3 replicates per condition were used if there was higher variability amongst samples. The specific replicate numbers (denoted by "n") are stated with the figure legends of each figure in the paper.

Replicates

Replicate information is provided within the methods sections at the beginning of the "Gene Expression", "Immunofluorescence", and "Whole-mount fluorescent in situ hybridization" sections, as well as within the figure legends of each of the figures. We did not exclude any outliers in the data sets presented. Sequencing data can be accessed on GEO (accession code GSE190281; reviewer token is ijmpumeypvenxgr).

The standard error of mean is represented as error bars on the graphs of every figure (as indicated in the figure legends). The statistical tests performed for each analysis are also indicated within the figure legends, along with relevant p-values.

Samples were allocated into control or experimental groups according to their genotype. For data collection and analysis samples were not masked as the phenotypes of the mutant samples made randomization/masking difficult.
