Replication numbers were given in the figure legends. Biological replication was defined as experiments repeatedly performed with different biological materials harvested. Technical replicates were also used in the RT-qPCR assay, where each reaction was repeated three times for the same cDNA, and the average amount was calculated and plotted of each gene for each animal. For the EM study, more than ten fields of images were captured and counted for each sample. Images with overlapped part were excluded, and the average number per field was calculated and plotted for each animal. This information can be found in the methods or figure legends.
