Replicates

From the methods: "Only cells with stable giga-ohm seals were used for data collection and subsequent analysis." And "All data are biological replicates. In some cases where technical replicates were performed (e.g. re-running the test protocol a second time on the same cell), we typically used the first series, unless there was a loss of seal resistance and recovery, in which case we used the second replicate. Selection in this case was blind to the result/outcome."



Statistical reporting

We include a table (table 1) with p values related to Figure 6, where we report effect of swapping extracellular domains on chimeric channels. Note that these data are ratios and thus a non-parametric statistical analysis was used. Figure 7 uses Student's t-test and we indicate significance with asterisks which are described in the figure legend.
