No explicit power analysis was used in this study. For calcium imaging studies, one fly was considered a replicate, and we collected samples from 5-11 flies/genotype. Sample sizes for each experiment are written in each figure legend.

### **Replicates**

- The data obtained should be provided and sufficient information should be provided to indicate the number of independent biological and/or technical replicates

Replicates for each experiment is written in the figure legend. For calcium imaging experiments, each data point is presented in the figure. All replicates were biological replicates.

Methodology is explained in the “Material and Methods, Imaging Analysis section” (pages 18-19).

For calcium imaging, data was excluded if gustatory projections did not respond strongly to at least two of the three presentations of the positive control, if projections responded to two or more presentations of the negative control, or if there was excessive movement.

### Statistical reporting
