Formal power analysis was not performed. Sample size was determined based on accepted standards of previous behavioral studies that trained animals on complex auditory tasks. Sample sizes are mentioned in Materials and Methods (line 637). Individual subject data is shown in Figure 3. Sample sizes are mentioned in the legends of Figures 4 – 10.

The exact number of trials for each stimulus paradigm is mentioned in Materials and Methods (Lines 124, 705, 708, 717, 729, 735, 746, 748, 756, 760, 766, 770). We trained the computational model 5 times to obtain nonoverlapping feature sets (mentioned in line 165).

We used repeated-measures ANOVAs to test the effect of each stimulus paradigm following the model specified in Equation 3 (Line 798). Multiple-comparisons corrected paired tests were used to evaluate statistical significance of responses to individual manipulations (Line 800). Exact p-values are provided in figure panels (Figs. 4B,D; Fig. 5C,F; Fig. 6C,F; Fig. 9C,F).
