Figure 2 and the corresponding results section directly discuss considerations of sample (and control) cohort size for PhIP-Seq-based work. In addition, given the low incidence of some of the diseases presented (APS1, IPEX, RAG deficiency) dictated that the number of samples was equal to the largest cohorts available.

PhIP-seq was performed once per sample and selected autoantigens were orthogonally validated using multiple approaches with replicates. This is described in "Methods" as well as in "Results".
