eLife asks authors to provide detailed information within their article to facilitate the interpretation and replication of their work. Authors can also upload supporting materials to comply with relevant reporting guidelines for health-related research (see <a href="EQUATOR Network">EQUATOR Network</a>), life science research (see the <a href="BioSharing Information Resource">BioSharing Information Resource</a>), or animal research (see the <a href="ARRIVE Guidelines">ARRIVE Guidelines</a> and the <a href="STRANGE Framework">STRANGE Framework</a>; for details, see <a href="eLife">eLife</a>'s <a href="Journal Policies">Journal Policies</a>).
